

### Important News from the IRS

### E-file Application URL Registration and Annual Self-Certification

This is a reminder that Online Providers must answer the annual Self-Certification questions beginning October 1, to ensure they comply with Publication 1345 IRS e-file security, privacy and business standards.

If you are an Authorization IRS e-file Provider who owns or operates a Website(s) that collects, transmits, stores, or processes taxpayer information, IRS also requires you to register the URL(s) for your Website on your e-file Application. The annual certification process includes the registration of these Websites. If you have not previously registered your URL(s), select the URL collection link on the e-file Application information page menu to register.



# IRS Extends October 15 and Other Upcoming Deadlines, Provides Other Tax Relief for Victims of Tropical Storm Imelda

Victims of Tropical Storm Imelda in parts of Texas, including the Houston area, have until Jan. 31, 2020, to file various individual and business tax returns and make payments, the Internal Revenue Service announced on October 7, 2019.

#### **PTIN Renewal Season Begins**

Preparer Tax Indentification Number (PTIN) applications and renewals for 2020 are now being processed. Anyone who prepares or assists in preparing federal tax returns for compensation must have a valid 2020 PTIN before preparing returns. All enrolled agents must also have a valid PTIN. See PTIN Requirements for Tax Return Preparers for more information.

#### 2 Million ITINs Set to Expire in 2019: To Avoid Refund Delays, Apply Soon

Taxpayers with expiring Individual Taxpayer Identification Numbers (ITINs) can get their ITINs renewed more quickly and avoid refund delays next year by submitting their renewal application soon, the Internal Revenue Service stated on October 10, 2019.

#### IRS Relief Provides Drought-Stricken Farmers, Ranchers More Time to Replace Livestock

Farmers and ranchers who were forced to sell livestock due to drought, may have an additional year to replace the livestock and defer tax on any gains from the forced sales, according to the IRS.
